EAGLE-US developed and implemented a grantmaking program to support the efforts of organizations in Africa to combat the illegal wildlife trade by increasing the effectiveness of wildlife enforcement. Grant funds were distributed to organizations for work in the following countries: Gabon, Cameroon, Kenya, Senegal, Guinea, Congo, Togo, Republic of Benin and Uganda. Through the efforts of EAGLE-US grantees in 2014, 194 traffickers were arrested or detained and 120 were successfully prosecuted.

EAGLE – U.S. accomplishes its charitable purposes by making grants to nonprofit organizations working in key African countries to support programs that are designed to increase wildlife law enforcement effectiveness, produce effective deterrents against wildlife crime, and combat the illegal wildlife trade so detrimental to the survival of elephants, apes, and other threatened species. The projects we fund follow a particular proven model (the “EAGLE model”), generally consisting of the following elements:

Investigations, including selecting, hiring, and training undercover investigators to successfully identify and infiltrate large-scale, illegal wildlife trafficking operations in order to develop concrete evidence that can be used to bring them to justice, in accordance with national and international laws in force; Operations, including assisting providing assistance to national law enforcement with in bringing about arrest about arrests and supervising law enforcement operations in the field in order to guard against corruption, such as bribery and the peddling; Legal Assistance, including helping government lawyers bring about the prosecution of wildlife offenses and monitoring the legal process at every step (arraignment, trial, sentencing, and incarceration) in order to intercept and combat corruption attempts; and Media, including preparing and distributing press releases and encouraging in-country TV news, radio news, and the written press to publicize the operational and legal successes, thereby educating the public on the illegality of wildlife poaching and trafficking, demonstrating that the laws are actively enforced, and increasing amplifying the deterrent effect of the legal successes.

In 2014, we awarded grants to a number of organizations that operate projects that follow the EAGLE model, including LAGA in Cameroon, PALF in Republic of Congo, AALF in Gabon, GALF in Guinea, TALFF in Togo, SALF in Senegal, B-AALF in Benin, Kenya, Benin and Democratic Republic of Congo. Collectively, the organizations operating funded projects, and the overall program itself, is called the EAGLE Network.” The African countries in which these organizations operate are key to combating the illegal wildlife trade, either by holding fragile populations of elephants, apes or other threatened species or, more importantly, by playing a central role in wildlife trafficking, which endangers wildlife populations

Before making any grants, EAGLE – U.S.’s Board of Directors conducts a pre-grant inquiry to ensure that the proposed grantee will use the grant funds in a manner that exclusively furthers our charitable and educational purposes. These inquiries focus on the identity, prior programmatic history, and experience of the potential grantee and its managers. We only make a grant to an organization when we are satisfied that the grantee intends to use and is capable of using the funds in the manner required, in close adherence to the procedures and policies we establish, and that sufficient political stability exists within the country for the funded project to be successful. EAGLE-US receives and maintains reports from each grantee at least annually on the use of grant funds, the grantee’s compliance with the terms of the terms of the a written grant agreement, and the progress made by the grantee toward achieving the purposes for which each grant is made.
