	Norfolk Area United Way provides human health and welfare services - Education, Income & Health - through partnerships with 30 agencies working in 22 counties in Northeast and North Central Nebraska covering a population of more than 144,000 people (per the 2000 Census)Our primary focus is to improve the lives of low-income people, however our goal is to improve the life of everyone in our communities. Norfolk Area United Way and 30 agencies work to help children and youth achieve their potential through education, ex providing after-school and mentoring programs for at-risk youth, assisting with basic needs, improving people's health by increasing access to critical healthcare services, reducing substance abuse, child abuse and domestic violence, and increasing health education and preventive care

	The Norfolk Area Child & Family Coalition was formed after an assessment was done in 2013 evaluating 10 child well-being indicators in the Norfolk area and comparing them to average in the state of Nebraska. This assessment revealed that out of 9 of the 10 indicators, in the Norfolk Area that were reviewed are worse than the average in Nebraska. The Coalition has brought together more than 40 different organizations, from Government agencies, corporations, and other non-profits to form the following work groups: Basic Needs, Prevention, Early Childhood, and Education K to 12, and Community Health. These groups are developing programs and services that will specifically address the 9 indicators. From the assessment, Norfolk Public Schools wrote for and received the 21st Century Grant worth over \$1 million to provide after-school programs in the Middle and Junior High Schools. The Early Childhood group is bringing the PWI program to the area that will address a high number of children entering kindergarten who are not ready for school, because they are under-developed socially, emotionally, and/or intellectually.
