THE CEO TOOK A LEAVE TO BE WITH HIS MOTHER AND FATHER DURING HIS MOTHER'S FINAL TWO MONTHS OF LIFE TO CARE FOR HIS MOTHER AND FATHER. SUBSEQUENT TO HIS MOTHER'S PASSING, THE CEO HAD TO ARRANGE FOR HIS MOTHER'S INTERMENT AND THE RELOCATION OF HIS FATHER TO A LOCATION WHERE HE WOULD BE ABLE TO LIVE WITH RELATIVE INDEPENDENCE. THE ENTIRE PROCESS DESCRIBED TOOK SEVERAL MONTHS TO COMPLETE, AND DURING THIS TIME, THE CEO OF MODEST NEEDS COULD NOT PARTICIPATE IN PREPARING THE DOCUMENTATION REQUIRED FOR THE ORGANIZATION'S ANNUAL AUDIT OR THE PREPARATION OF THE ORGANIZATION'S FORM 990. THESE TASKS HAVE NOW BEEN COMPLETED AND WE HOPE THAT, GIVEN MODEST NEEDS' HISTORY OF FILING ALL REQUIRED FORMS IN A TIMELY MANNER, THE IRS WILL DETERMINE THAT, GIVEN THE SMALL SIZE OF MODEST NEEDS, THE FOREGOING EVENTS CONSTITUTE A REASONABLE CAUSE FOR THIS REPORT'S LATENESS AND WILL PLEASE ABATE ANY PENALTIES THAT MIGHT OTHERWISE BE DUE FROM THE ORGANIZATION.
