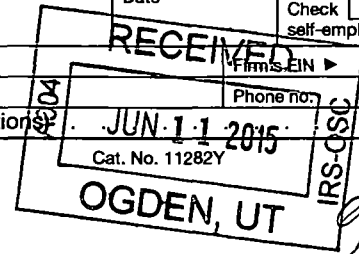

Aloha State Games/Hawaii Senior Olympics: Kahoomiki organizes and manages the activities of these statewide multi-sport events. Games activities take place in June, July, August and November, and are organized primarily by volunteers. Primary source of funds is entry fees; approx. 1,500 participants, all amateurs. Success measured by number of sports and number of competitors.

4b (Code:) (Expenses \$ **42490** including grants of \$) (Revenue \$ **35107**)

Keiki Fun Run: A community fun run designed to impress upon children the value of staying physically active. In 2014, there were more than 1,500 participants from more than five dozen elementary schools on Oahu. Participants earn credits for their school's PE program.

Hawaii Afterschool Alliance: During 2014, Kahoomiki undertook the formation of a statewide network of afterschool partners, later called the Hawaii Afterschool Alliance. Activities and expenses related to forming this organization, including a statewide summit of afterschool partners attended by 80+ representatives of afterschool providers, dignitaries, and officials. This activity was undertaken at the request of community leaders.

Part III, Item 3: One of the largest, and most prominent programs of Kahoomiki in the past has been our Fun 5 program which provides training, equipment and curriculum for physical activity and nutrition education in the afterschool hours within the statewide A+ afterschool program. Funding for that program in 2014 was supposed to come from a state Grant In Aid, awarded in the spring of the year. However, those funds were never released during 2014, and we were forced to put that program on hold for the calendar year 2014. We are hopeful we can reprise the program in 2015.

Part VI, Section B, conflict of interest policy: Hawaii law governing non-profits has strict conflict-of-interest regulation. In addition, Kahoomiki is a small organization, with a small board and no executive committee, and we monitor all activities to avoid any conflict of interest.

Part VII – Paula Adams – Paula is an independent contractor who receives a retainer fee from Kahoomiki to assist with management of activities. She also serves as treasurer of the organization, but is not a member of the board of directors. Her activities are supervised by the president.
