The UNFCU Foundation's \$50,000 grant to the United Nations Population Fund Campaign to End Fistula provided funding to 400 repaired and incurable obstetric fistula patients in Nigeria providing an opportunity for social reintegration and continuous monitoring of patient progress. Funds were used to conduct an 8 month rehabilitation and intensive training program for women to acquire skills in various trades and crafts. Literacy workshops for basic reading and writing were conducted as well as psycho-social counseling and health talk sessions. The women were also trained as Fistula Advocates in addition to their vocational training.
