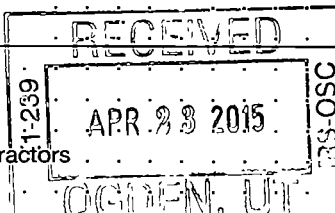

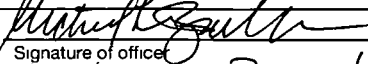

The purpose of the organization is to collect used furniture and other household items and redistribute to teenagers who are emancipated from foster care in Summit County, Ohio. Each recipient is identified by Summit County Children's Services and passed along to Chair-ity to satisfy delivery of the items to the new apartment of the recipient, who are often just 18 years of age.

Part I, question 20: Chair-ity received \$5,400 from individual donations. The funds are used to purchase new mattresses and bed frames, along with other household items that the organization has not collected from donors. Chair-ity has also received furniture donations, such as chairs, sofas, tables, lamps, and dressers that are inventoried and held until delivered to a needy recipient as identified by Summit County Children's Services. No deliveries were made in 2014 as Chair-ity was launched later in the year. Deliveries did begin in January 2015.
