Statement Regarding Reasonable Cause for Late Filing Form 990-PF

The Form 990-PF for the organization was not timely e-filed for a reasonable cause. See attached copy of Electronic Filing Client Status History. The return was transmitted for e-file on the due date of May 15, 2015. The return was rejected due to the return type not matching the IRS master file. On May 18, 2015 I called the IRS E-file help desk who referred the error to a non-profit e-filing specialist.

On May 26, 2015 (after the 10 day e-file grace period) I received a call from Tiwana Holland (IRS #143400?). She indicated the IRS records did not reflect the organization to be a Private Foundation. I gave her the information indicating that the organization had received a determination dated April 16, 2015 (copy attached) indicating they were a 501(c)(3) classified as a Private Foundation. Tiwana indicated that she would have the master file changed to reflect PF status and she would contact me when the change had been made so I could re-submit the return. She contacted me again on May 27, 2015 to indicate the change had been made and that the return should be re-submitted.

Based on the above, the return should be considered as timely filed and not be assessed any late filing penalties.
