Legal Foundation published 18 articles in the Kansas Farm Bureau Leader Letter that is disseminated to over 36,000 individuals. These articles include topics, such as: conservation easements, umbrella insurance, well plugging, entrepreneurship, food labeling, preserving the family farm, business structures, and trucking regulations.

In addition, the Legal Foundation staff provided over 40 educational seminars to approximately 1,800 individuals, regarding: oil & gas leases, transmission line easements, fencing, farm leases, agri-tourism, spray drift, zoning, succession/estate planning, endangered species (Lesser Prairie Chicken - LPC) and trucking regulations. Staff prepared legal strategy and campaign against the designation of the LPC as "threatened" by the USFWS. Staff prepared White Paper for Local Food Systems and worked on agricultural land reclassification, water flow meters zoning, drones, data mining and numerous energy concerns.

Finally, the Legal Foundation works with such organizations such as the Kansas Bar Association (KBA), Kansas Corn Growers, KARL program, Kansas Forage and Grassland program, Women Managing the Farm, Kansas Society of Farm Managers and Rural Appraisers program, Kansas State Extension (KSU), along with KFB members. The Legal Foundation in cooperation with the KBA hosts Agricultural Law Seminars for attorneys from around the State of Kansas. The hope is to educate rural, private practitioners and urban attorneys, business leaders and academics with timely court cases,

Salary. Following discussion of annual goals and progress, the Executive Committee reviews and develops a salary recommendation for presentation to the full Board for approval and presentation to members of the Leadership Team.

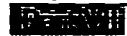
