WEST METRO MEDICAL FOUNDATION
AND
EAST METRO MEDICAL SOCIETY FOUNDATION**

This shall constitute the Plan of Merger by and between West Metro Medical Foundation, a Minnesota nonprofit corporation ("West Metro"), and East Metro Medical Society Foundation, a Minnesota nonprofit corporation ("East Metro"), pursuant to Minnesota Statutes Chapter 317A. West Metro and East Metro are referred to herein as "Constituent Corporations."

I. EFFECTIVE DATE.

The effective date of the merger shall be January 1, 2015 (the "Effective Date"). ✓

II. SURVIVING CORPORATION.

East Metro shall be the Surviving Corporation from and after the Effective Date.

III. NAME.

The name of the Surviving Corporation shall be Twin Cities Medical Society Foundation. ✓

IV. LOCATION.

The registered address and main business office of the Surviving Corporation from and after the Effective Date will be 1300 Godward Street NE, Suite 2000, Minneapolis, Minnesota, 55413.

V. ARTICLES OF INCORPORATION. The Articles of Incorporation of the Surviving Corporation from and after the Effective Date shall be in the form attached hereto as Exhibit "A."

VI. MEMBERS.

From and after the Effective Date, the sole member of the Surviving Corporation shall be Twin Cities Medical Society.

VII. GOVERNANCE/MANAGEMENT.

- A. Board of Directors. The number of directors, the qualifications of directors, the method of election of directors, and the terms of office of directors shall be as set forth in the Bylaws of the Surviving Corporation.
- B. Officers. The qualifications of officers and the method of election/appointment of officers shall be as set forth in the Bylaws of the Surviving Corporation.

VIII. FINANCIAL MATTERS.

- A. General Operating Funds. Subject to the provisions of paragraph B of this Article VIII, all investment accounts and other financial resources of the Constituent Corporations shall become part of the general operating funds of the Surviving Corporation as of the Effective Date.
- B. Restricted Funds. As of the Effective Date, any restricted funds of either Constituent Corporation, whether restricted by the donor of such funds, or by the Board of Directors of such Constituent Corporation, specifically including, but not limited to, the Boeckman Fund of East Metro and the Eitel Fund of West Metro, shall become the restricted funds of the Surviving Corporation (collectively referred to as "Restricted Funds). The Surviving Corporation shall have authority to spend or encumber any Restricted Funds only to the extent provided in the Bylaws.

- C. Assumption of Assets and Liabilities. The Surviving Corporation shall assume all of the assets and liabilities of both Constituent Corporations as of the Effective Date.
- D. Assignment of Contracts. All contracts to which either Constituent Corporation is a party shall be assigned to the Surviving Corporation, by operation of law, as of the Effective Date.
- E. Gifts and Grants. All gifts or grants made to either Constituent Corporation, whether before or after the Effective Date, shall inure to the benefit of the Surviving Corporation as of the Effective Date.

IX. TAX-EXEMPT STATUS.

- A. Section 501(c)(3) Status. From and after the Effective Date, the Surviving Corporation shall be a tax-exempt, charitable and educational organization described in §501(c)(3) of the Internal Revenue Code of 1986 (the "Code").
- B. Public Charity Status. From and after the Effective Date, the Surviving Corporation shall be a public charity, and not a private foundation.

X. APPROVALS.

- A. West Metro Approval. This Plan of Merger is subject to approval by a majority of the directors of West Metro then in office.
- B. East Metro Approval. This Plan of Merger is subject to approval by a majority of the directors of East Metro then in office.

XI. NOTICE.

Each of the Constituent Corporations shall give notice of the merger to the

Minnesota Attorney General following the Effective Date pursuant to Minnesota Statutes Section 317A.811, Subd. 6.

**EXHIBIT A
AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
EAST METRO MEDICAL SOCIETY FOUNDATION**

**ARTICLE I
NAME**

The name of this corporation is: Twin Cities Medical Society Foundation.

**ARTICLE II
PURPOSES**

This corporation is a Minnesota nonprofit corporation governed by Minnesota Statutes Chapter 317A, and shall be organized and operated exclusively for charitable, educational or scientific purposes within the meaning of Sections 170(c)(2), 501(c)(3), 2055(a)(2), and 2522(a)(2) of the Internal Revenue Code of 1986, as now enacted or hereafter amended (the "Code").

Subject to the limitations of the foregoing purposes, this corporation shall be operated exclusively to engage in, advance, support, promote, and administer charitable, educational and scientific activities, causes, and projects of every kind and nature whatsoever in its own behalf, or as the agent, trustee, or representative of others, all to the end of promoting health; providing relief of the poor, the distressed or the underprivileged, advancing education and science; or lessening the burdens of government.

This corporation at all times shall be operated, supervised, or controlled by or in connection with, Twin Cities Medical Society, a Minnesota nonprofit organization described in Section 501(c)(6) of the Code, but which would be described in Section 509(a)(2) of the Code if it were an organization described in Section 501(c)(3) of the

Code, as contemplated by section 509(a)(3)(B) of the Code.

ARTICLE III POWERS

Notwithstanding any other provisions of these Articles of Incorporation, all of the work of this corporation shall be carried on, and all funds of this corporation, whether income or principal and whether acquired by gift or contribution or otherwise, shall be used and applied exclusively for charitable, educational, or scientific purposes benefitting this corporation, directly or indirectly, and in such manner that no part of the net earnings of this corporation will in any event inure to the benefit of any officer or director of this corporation or of any other corporation, organization, foundation, fund or institution, or any other individual.

This corporation shall not engage, otherwise than as an insubstantial part of its total activities, in activities that in themselves are not in furtherance of one or more of the exempt purposes specified in Section 501(c)(3) of the Code, and regulations issued thereunder. No part of the principal, assets or net income of this corporation shall in any event be paid or contributed to any other corporation, organization, foundation, fund, institution or governmental body, any substantial part of the activities of which consists of carrying on propaganda or otherwise attempting to influence legislation or which participates or intervenes in any political campaign on behalf of any candidate for public office, nor shall this corporation itself engage in such activities in any way, directly or indirectly, except to the extent, if any, permitted by the Code and regulations issued thereunder.

No officer or director of this corporation or other private individual shall be

entitled to share in the distribution of the corporate assets on liquidation, dissolution, or winding up of this corporation. However, nothing contained in these Articles of Incorporation shall be construed to prevent distribution of the properties of this corporation to another distributee, otherwise properly made in accordance with the provisions of these Articles of Incorporation and the purposes herein stated, solely by reason of the fact that one or more of the directors or officers of this corporation may be connected or associated with the distributee as shareholder, member, director, officer or in any other capacity.

ARTICLE IV NONDISCRIMINATION

This corporation shall not unlawfully discriminate on the basis of race, color, creed, religion, national origin, sex, marital status, status with regard to public assistance, sexual orientation, disability or age.

ARTICLE V INUREMENT OF INCOME

This corporation does not and shall not afford pecuniary gain incidentally or otherwise to any private individual.

ARTICLE VI DURATION

The duration of this corporation shall be perpetual.

ARTICLE VII REGISTERED OFFICE

The registered office of this corporation shall be located at 1300 Godward Street N.E., Suite 2200, Minneapolis, Minnesota 55413.

ARTICLE VIII
SOLE MEMBER

The sole Member of this corporation shall be Twin Cities Medical Society. The rights of the sole Member shall be set forth in the Bylaws of this corporation.

ARTICLE IX
DIRECTORS

The management and governance of this corporation shall be vested in a Board of Directors. The initial Board of Directors shall be comprised of eighteen (18) persons. Thereafter, the Board of Directors shall be comprised of that number of directors established by the Board of Directors. The qualifications, method of election, and terms of office of the directors shall be fixed by the Bylaws of this corporation.

Any action required or permitted to be taken at a meeting of the Board of Directors may be taken by written action signed, or consented to by electronic communication, by the number of directors that would be required to take the same action at a meeting of the Board of Directors at which all directors were present.

ARTICLE X
DISSOLUTION

Upon the dissolution of this corporation, the Board of Directors shall, after paying or making provisions for the payment of all the liabilities of this corporation, dispose of all the assets of this corporation exclusively for the purposes of this corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law),

as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the District Court of the county in which the principal office of this corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for charitable, educational or scientific purposes.

ARTICLE XI
AMENDMENT

These Articles of Incorporation may be amended at any time and from time to time by the affirmative vote of seventy five percent (75%) of the directors then in office.
