The F. Marian Bishop Fellowship was inaugurated in 2000 to prepare senior faculty to assume positions of senior responsibility in academic medicine and health care leadership. F. Marian Bishop, PhD, envisioned this program and supports the program through her F. Marian Bishop Charitable Trust. The program funds 1-4 fellows per year.

The Foundation responded to the expressed needs of STFM members for funding research and education by establishing the Group Project Fund in 2008. It was designed to reward creative and collaborative proposals of STFM group members. The outcomes of projects will benefit group members, STFM, and the discipline of Family Medicine.

Since the inception of the New Faculty Scholars Award in 1988, more than 100 STFM members have received these awards. The award

is intended to provide STFM members who are in their first 2 years as full time faculty and who exhibit outstanding leadership

potential the opportunity to attend the STFM Annual Spring Conference. This introduction to over \$1,000 STFM members leads

to community building activities such as participation in groups and membership on committee and task forces.

Three to seven scholarships are awarded annually.

PROGRAM ENHANCEMENT EXPERIENCE (Expenses = \$4750 Grants = \$4000 Revenue = \$25)

The Program Enhancement Award, initiated in 2013, provides funding for family medicine programs to implement enhancements at their

institutions while developing the leadership skills of family medicine faculty. Preference is given to programs whose project leaders are early

in their academic careers. This award replaces the Faculty Enhancement Experience Award. Up to four awards are available per year.

CARMICHAEL AWARD (Expenses = \$2303 Grants = \$0 Revenue = \$0)

Program that honors an individual for outstanding leadership in advancing family medicine as a discipline. The achievements

and activities are clearly recognized as enhancing family medicine education by improving resources available for its support.

INTERNATIONAL SCHOLAR AWARD (Expenses = \$5176 Grants = \$3676 Revenue = \$776)

Some nations need help fostering the delivery of health care through the family medicine model. The Foundation established this award to

support participation by international family medicine educators by awarding a scholarship to attend the STFM Annual Spring Conference

Leading Change is a joint effort of ADFM and STFM to develop and disseminate a curriculum and resources on leading change for family medicine education. The curriculum and resources will address the need for skills in leading change for faculty at all levels of their careers.

BLANCHARD LECTURE (Expenses = \$2152 Grants = \$500 Revenue = \$0)

The Leland Blanchard Memorial Lecture was established in memory of Leland Blanchard, MD in 1979. Dr. Blanchard was a major contributor to the development of family medicine and was a charter member of the STFM. This lecture is a program component of each STFM Annual Spring Conference.

F. MARION BISHOP AWARD (Expenses = \$1346 Grants = \$0 Revenue = \$1346)

Established in 1990 in honor of F. Marion Bishop, this award is presented annually by the STFM Foundation to honor individuals who have significantly enhanced the credibility of family medicine by a sustained, long term commitment to family medicine in academic settings.

MSE STUDENT SCHOLARS PROGRAM (Expenses = \$6000 Grants = \$6000 Revenue = \$6000)

The Conference on Medical Student Education Student Scholarship is awarded to medical students with both an interest in family medicine and a potential for an academic career. Recipients are awarded a \$500 scholarship, a 1 year STFM membership, and a complimentary registration to attend the STFM Conference on Medical Student Education.

SHOTS PROGRAM (Expenses = \$6500 Grants = \$6500 Revenue = \$0)

The STFM Group on Immunization has for many years maintained a product that provides the most current immunization recommendations for use by family medicine physicians. The most recent development for Shots is the development of the Shots immunization app usable on android and i-phones. Content is updated annually.
