Advocates for Families First NACAC continued its collaboration with the National Foster Parent Association and Generations United to advocate for foster, adoptive, and kinship care families and support organizations that serve these families As part of this collaboration, in 2014, we developed a joint advocacy agenda, which we released at a briefing on Capitol Hill In the fall, we began working with coalitions in five states to help them coordinate and advance advocacy for adoptive, foster, and kinship care families We also offered training to hundreds of support organization leaders through seven webinars and several conference presentations, and provided technical assistance to help enhance the advocacy or support services of several adoption, foster, or kinship care-serving organizations Advocates for Families First also developed a resource-rich website visited by more than 1,000 individuals, and contracted for a study of media themes and messaging related to foster care, kinship care, and adoption

Public Education and Conference The NACAC conference in Kansas City, Missouri served more than 900 adoptive parents, adoption professionals, and others committed to achieving permanence for children in foster care Participants attended about 90 educational sessions where they learned how to better support children with special needs, recruit and prepare permanent families for kids, replicate model programs, change the system to improve outcomes for vulnerable children and their families, and much more NACAC offered training in person and through webinar to more than 4,000 adoption community members during the year on topics such as parent group development, effective support services for families, adoption assistance, transracial parenting, core issues in adoption, and adoption competence NACAC staff and volunteers also help hundreds of prospective adopters find the information the need to navigate the adoption process, and the NACAC website provides in-depth information on adoption issues to tens of thousands of site visitors each year

Community Champions Network NACAC continues to support 23 communities coalitions of individuals who are advocating for improved access to post-adoption services in their communities In these communities across the U S and Canada, advocates have successfully secured funding to launch new post-adoption services programs, started support groups, created youth speak out teams of former foster youth and adoptees, hosted training for adoption professionals, started new Facebook support groups, and much more In 2014, CCN also worked with more than 30 adoptive parent groups to improve the services they provide to these families In May, we sponsored trainings for 25 youth leaders and 15 parent group leaders where they learned about advocacy, support, and leadership development At the annual NACAC conference in July 2014, we provided additional leadership and advocacy training to 30 youth and 25 parents
