director at an institution files an application with ICPI. ICPI judges the

ICPI established this program to support trainee participation in scientific meetings
organized by its member societies. The award is intended to offset the travel cost
for attending the meeting. Awardees must currently be a trainee (medical student,
graduate student, resident, or fellow) member of one of the sponsoring societies or
associate members of ICPI. In 2014, ICPI awarded 21 travel awards.
