Gross salary for G-4 staff, which is tax exempt, is determined based on prevailing salary for US citizens holding comparable positions. Salary Adjustments, representing tax deductions and withholding equivalent to US citizens, are made to arrive at net pay (estimated taxable income for US citizens) for G-4 Visa holders. The deduction is based on a combination of information provided by staff (marital status, dependents, etc) and average itemized deductions for comparable US salaries. The net is what is actually paid to G-4 staff and recorded as expense; the gross salary is only maintained for administrative purposes and computation of retirement contribution and life/AD&D benefits and does not pass through the books.
