	CTWO completed MAAP 2014 with host sites in Pittsburgh, PA, Oakland, CA, Boston, MA, and Atlanta, GA, graduating another crew of 16 organizing apprentices. Apprentices helped organize and promote policies and campaigns to support racial equity in public education through the Great Public Schools (GPS) coalition (Pittsburgh), food justice in historically under-invested communities of color through the Peoples Grocery (West Oakland), immigrant workers rights in the New England Area through the Immigrant Worker Center Collaborative (Boston), formerly incarcerated women and women with records through the Racial Justice Action Center (Atlanta), and racial and economic justice through the Black Organizing Project (Oakland). Apprentices did contact work in communities, surveying, and engaging in door to door conversations on such issues. MAAP culminated in our annual graduation with a grassroots fundraiser in New York City. CTWO hosted five Community Action Trainings (CAT) in Oakland, New York, Atlanta, Baltimore, and Denver. Besides MAAP recruitment, CAT provided entry-level organizer training to staff and members of community based organizations, workers centers, and other nonprofit organizations on campaign development, leadership training, contact work, grassroots fundraising techniques, and social movement analysis. CTWO organizers along with MAAP apprentices developed a movement infrastructure of organizers of color that facilitated local progressive organizations in their capacity to move a racial justice agenda in Pittsburgh Public Schools. CTWO provided capacity building and campaign consultation support to the GPS coalition. Over the course of the 8-week apprenticeship, MAAP apprentices engaged in door to door outreach of 1000 residents including students, parents, teachers, school staff, and other members in urban cores of Pittsburgh mobilizing 60 percent of contacted residents to sign pledge cards in the fight for racial and economic justice in education reform. CTWO helped build out the National Taxi Workers Alliances (NTWA) newest local in San Francisco, CA. Our organizing efforts helped the San Francisco Taxi Workers Alliance (SFTWA) become the fastest growing local in the NTWA. This work continues our multi-year organizational relationship with the NTWA in which CTWO provided strategic planning support for the taxi worker local affiliation process in Austin, TX and the DC Maryland area. SFTWA represents over 5,000 taxi workers and CTWO was instrumental in providing organizing and infrastructure support in various direct actions across the Bay area. Our organizers worked with SFTWAs members and the board in crafting tactics that would help in the fight against companies like Uber, Lyft, and Sidecar which are undermining safety regulations in the transportation industry.
