During 2014, the organization hosted policy briefings in the District of Columbia, Kentucky, Texas, and South Dakota, that convened elected officials, academics, and community leaders to discuss conservative policy perspectives and solutions.

The organization affiliated with Senior Fellows, who serve as subject matter experts in several policy areas. The Fellows supply the American public with the tools and intellectual arguments to support their views, as well as to educate the public concerning conservative policies and principles. The organization launched the Center for Criminal Justice Reform. Its director participated in a series of discussions and seminars, and published op-eds to advocate for justice reform. The organization analyzed and rate the 2013 voting records of all members of Congress, as well as the records of 25 state legislatures.
