**ARTICLES OF AMENDMENT AND RESTATEMENT
OF
NATIONAL AQUARIUM IN BALTIMORE FOUNDATION, INC.**

National Aquarium in Baltimore Foundation, Inc., a Maryland nonstock corporation (hereinafter called the "Corporation"), hereby certifies to the State Department of Assessments and Taxation of Maryland that:

FIRST: The Corporation desires to amend and restate its Charter as currently in effect. Therefore, the Charter of the Corporation is hereby amended and restated by striking out in its entirety the existing Charter and substituting in lieu thereof the following:

FIRST: The name of the corporation (which is hereinafter called the "Corporation") is:

National Aquarium Foundation, Inc.

SECOND: The Corporation is organized and shall be operated exclusively as a nonstock charitable "supporting organization" within the meaning of Section 501(c)(3) and Section 509(a)(3) of the Internal Revenue Code of 1986, as amended, and the Regulations thereunder, as they now exist or may hereafter be amended (hereinafter, collectively, the "Code"), for the following purposes:

(a) To receive and administer funds for, to establish, maintain, supervise, coordinate, assist and perform planning and other functions for, and to carry out the charitable, scientific and educational purposes of the Center for Aquatic Life and Conservation, Inc., National Aquarium, Inc., and any other charitable organizations that may become affiliated with the Corporation; provided, however, they are exempt from taxation under Section 501(c)(3) and Section 509(a)(1) or 509(a)(2) of the Code (the "Beneficiaries"). The Corporation may support such organizations directly or through the National Aquarium, Inc.

(b) To receive and hold property from any person, firm, foundation, corporation, or governmental agency that will constitute the endowment funds of the Beneficiaries;

(c) To own, hold, manage, invest and reinvest all such property received by it, to use and apply the net income and principal of all such property in such manner and in such time as the Corporation may deem best for the use or benefit of the Beneficiaries; and

(d) The Corporation shall have and exercise to the extent necessary or desirable for the accomplishment of any of the aforesaid purposes, and to the extent that they are not inconsistent with the charitable purposes of the Corporation, any and all powers conferred upon nonstock corporations by the Maryland General Corporation Law.

THIRD: The post office address of the principal office in this State is 501 East Pratt Street, Pier 3, Baltimore, Maryland 21202. The resident agent of the Corporation in this State is CSC-Lawyers Incorporating Service Company whose address is 7 St. Paul Street, Suite 1660, Baltimore, Maryland 21202. The resident agent is a Maryland Corporation.

FOURTH: The Corporation is not authorized to issue any capital stock. National Aquarium, Inc., acting through its Board of Directors, Executive Committee or such officer(s) designated by its Board of Directors from time to time, shall be the Corporation's sole member (the "Member"). The rights, privileges and qualifications of the Member are as provided in this Charter and the Bylaws of the Corporation.

FIFTH: The business and affairs of the Corporation shall be managed under the direction of its Board of Directors, consisting of the following persons who shall serve until their successors are elected and qualify:

Charles E. Knudsen, III
Michael Batza
Frank Rosenberg
Anna L. Smith

Directors shall be elected annually by the Member of the Corporation as provided in the Bylaws. The number of directors may be increased or decreased in the manner provided in the Bylaws but shall never be less than three.

Additionally, as provided in the Bylaws and for such terms as provided in the Bylaws, resolutions or otherwise, the following persons shall serve as non-voting ex-officio directors of the Corporation:

SIXTH: The powers of the Corporation shall be subject to the following terms, provisions and limitations:

(a) No part of the net earnings of the Corporation shall inure to the benefit of any member, director or officer of the Corporation, or any private person, except that reasonable compensation may be paid for services actually rendered to or for the Corporation, and no member, director or officer of the Corporation, or any private person shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation. Except as provided and permitted under Sections 501(h) and 4911 of the Code, no substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidates for public office.

(b) During any period that the Corporation is deemed to be a private foundation as described in Section 509(a) of the Code, the Corporation:

(i) shall distribute its income for each taxable year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Code;

(ii) shall not engage in any act of self-dealing as defined in Section 4941(d) of the Code;

(iii) shall not retain any excess business holdings as defined in Section 4943(c) of the Code;

(iv) shall not make any investments in such manner as to subject it to tax under Section 4944 of the Code; and

(v) shall not make any taxable expenditures as defined in Section 4945(d) of the Code.

(c) Notwithstanding any other provisions of these Articles, the Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)(3) of the Code or by an organization, contributions to which are deductible under Section 170(c)(2) thereof.

(d) In the event of the liquidation, dissolution or winding up of the Corporation in any manner or for any reason whatever, all of the assets of the Corporation after the payment of the obligations and liabilities of the Corporation shall be transferred to the Corporation's Member or its successor; provided, however, that if the Member or its successor does not qualify under the provisions of Section 501(c)(3) of the Code, is not in existence or is not willing or able to accept such assets, then the assets of

the Corporation shall be transferred to one or more domestic corporations or associations as may be selected by the Corporation's directors; provided, further, however, that any transferee corporation shall qualify under the provisions of Section 501(c)(3) of the Code.

(e) To the maximum extent that limitations on the liability of directors and officers are permitted by the Maryland General Corporation Law and the Code, as from time to time amended, no director or officer of the Corporation shall have any liability to the Corporation or its members for money damages. This limitation on liability applies to events occurring at the time a person serves as a director or officer of the Corporation whether or not such person is a director or officer at the time of any proceeding in which liability is asserted. No amendment or repeal of this paragraph, or the adoption of any provision of the Corporation's Charter inconsistent with this paragraph, shall apply to or affect in any respect the liability of any director or officer of the Corporation with respect to any alleged act or omission which occurred prior to such amendment, repeal or adoption.

(f) To the maximum extent permitted by the Maryland General Corporation Law and the Code, as from time to time amended, the Corporation shall indemnify its currently acting and its former directors against any and all liabilities and expenses incurred in connection with their services in such capacities, shall indemnify its currently acting and its former officers to the full extent that indemnification shall be provided to directors, and shall indemnify its employees and agents and persons who serve and have served, at its request as a director, trustee, officer, partner, director, employee or agent of another corporation, partnership, joint venture or other enterprise. The Corporation shall, also to the same extent, advance expenses to its directors, officers and other indemnified persons, if any, and may by Bylaw, resolution or agreement make further provision for indemnification of directors, officers, employees and agents. No amendment or repeal of this paragraph, or the adoption of any provision of the Corporation's Charter inconsistent with this paragraph, shall apply to or affect in any respect the indemnification of any director or officer of the Corporation with respect to any alleged act or omission which occurred prior to such amendment, repeal or adoption.

SEVENTH: The Corporation reserves the right to make from time to time, by the vote or written assent of a majority of its directors and subject to the approval of the Member, any amendments to these Articles which may now or hereafter be authorized by law.

SECOND: The Amendment and Restatement of the Charter of the Corporation herein made was recommended and approved by at least a majority of the Corporation's trustees, acting in their capacities as both trustees and members, at a meeting duly held on September 10, 2014, at which a quorum was present.

THIRD: The provisions set forth in the above articles of amendment and restatement are all of the provisions of the Corporation's Charter currently in effect as hereby amended.

FOURTH: The current address of the principal office of the Corporation is as set forth in Article Third of the foregoing amendment and restatement of the Charter.

FIFTH: The name and address of the Corporation's current resident agent is as set forth in Article Third of the foregoing amendment and restatement of the Charter.

SIXTH: The Corporation currently has 4 voting directors and 1 ex-officio, nonvoting director. The names of those currently in office are as set forth in Article Fifth of the foregoing amendment and restatement of the Charter.

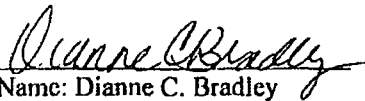
