Food Bridge Program - ODB coordinates a weekly food program by finding and matching a group of volunteers to a list of clients
referred by government agencies. The volunteers typically pay for groceries and/or gift cards and deliver them directly to the clients.
In addition, ODB maintains a food pantry in order to make emergency deliveries to families with urgent needs.
During 2014, approximately 16 volunteer organizations participated in the program and assistance
was provided to 828 individuals.

Seasonal Programs - ODB works with Fairfax County government agencies, community based organizations, faith communities,
area businesses, individual families, and other volunteers to provide school supplies and holiday meals, gifts of clothing and toys,
and store gift cards to clients referred by government agencies, faith communities, and not-for-profit organizations. ODB served
13,635 individuals in 2014.

Community Education Program - ODB raised community awareness about the struggles of our clients through several activities.
1,600 people attended ODB's community awareness events. ODB staffed an information table at multiple community fairs and

and programs, all of which engage the community. ODB participated in Chamber of Commerce activities. ODB has increased
followers in social media venues.
