COLLEGE PREPARATION AND SCHOLARSHIPS IN 2014, PROGRAMS WERE ACCOMPLISHED, IN PART, THROUGH THE SUPPORT OF 26,100 VOLUNTEER HOURS VALUED AT APPROXIMATELY \$1.3 MILLION. THE ORGANIZATION ACCOMPLISHES ITS MISSION BY PROVIDING SUSTAINED TUTORING, MENTORING AND COLLEGE PREPARATORY ENRICHMENT ACTIVITIES TO OVER 160 STUDENTS IN ITS WEEKLY ACADEMIC MENTORING PROGRAM AND AN ADDITIONAL 250 STUDENTS THROUGH ITS OUTREACH ACTIVITIES. THE ORGANIZATION HAS A PROVEN TRACK RECORD OF SUCCESS FOR STUDENTS IN TERMS OF ACADEMIC PERFORMANCE AND ENTRANCE TO INSTITUTIONS OF HIGHER EDUCATION. IN 2014, 100 PERCENT OF THE SENIORS ENROLLED IN THE ORGANIZATION'S PROGRAM GRADUATED FROM HIGH SCHOOL AND 100 PERCENT OF THESE STUDENTS WERE ACCEPTED AND ENROLLED INTO COLLEGE. MOST SIGNIFICANTLY, COLLEGE BOUND LAUNCHED A VIRTUAL MENTORING PROGRAM IN 2012 THAT IS NOW SUPPORTING OVER 100 ALUMNI ENROLLED IN COLLEGE TO DEGREE COMPLETION. IN 2014, \$64,975 IN SCHOLARSHIPS WERE PAID TO STUDENTS TO ASSIST WITH COLLEGE COSTS. THE COMPONENTS OF THE ORGANIZATION'S COLLEGE PREPARATION AND SCHOLARSHIPS PROGRAM INCLUDE ACADEMIC MENTORING, WRITING WORKSHOPS, SAT/ACT PREPARATION, COLLEGE TOURS, SCHOLARSHIPS, A COLLEGE FAIR, A CAREER NIGHT AND VIRTUAL MENTORING. FOR ACADEMIC MENTORING, STUDENTS MEET WITH THEIR MENTOR ONCE PER WEEK FOR TWO HOURS AT ONE OF THE SIX COMMUNITY-BASED-SITES-BEACON HOUSE, CESAR CHAVEZ PUBLIC CHARTER SCHOOL, THE DEPARTMENT OF EDUCATION, SHERWOOD RECREATION CENTER, BLACK ENTERTAINMENT TELEVISION (BET), OR THE AMERICAN INSTITUTES FOR RESEARCH. THROUGH WRITING WORKSHOPS, VOLUNTEER WRITING COACHES HELP STUDENTS DEVELOP THE WRITING SKILLS NEEDED FOR COLLEGE APPLICATIONS AND FINANCIAL SCHOLARSHIPS. STUDENTS ARE ALSO PROVIDED MATH REMEDIATION AND ENRICHMENT THROUGH A MATH LAB AT THE ORGANIZATION'S MAIN OFFICE THREE NIGHTS A WEEK AND AN ONLINE STUDY PROGRAM. THE ORGANIZATION AWARDS SCHOLARSHIPS TO QUALIFIED PARTICIPANTS OF ITS ACADEMIC MENTORING PROGRAM AND LAST YEAR AWARDED OVER \$140,000. A COLLEGE EXPLORATION DAY WAS LAUNCHED TO INCREASE OUTREACH AROUND THE CITY AND PROVIDE EARLY EXPOSURE TO A COLLEGE-GOING CULTURE. THIS ONE DAY EXPERIENCE PROVIDES AN ADDITIONAL 250 SEVENTH AND EIGHTH GRADERS ACROSS THE CITY THE OPPORTUNITY TO INTERACT WITH PROFESSIONALS REPRESENTING AN ARRAY OF COLLEGES AND CAREER FIELDS AS WELL AS COLLEGE BOUND STAFF AND ALUMNI. A FURTHER EXTENSION OF THE MENTORING PROGRAM IS A 'VIRTUAL' COMPONENT FOR THE PROGRAM'S ALUMNI THAT INCLUDES COLLEGE COACHING, COLLEGE TRANSITION AND SUPPORT, AND ASSISTANCE WITH OBTAINING INTERNSHIPS. ALL COLLEGE FRESHMEN ARE VISITED BY COLLEGE BOUND STAFF AT LEAST ONCE AND MORE IF NEEDED. THE ORGANIZATION ALSO PROVIDES DROP-IN SERVICES TO BOTH STUDENTS AND RECENT GRADUATES WHO ARE NOT ENROLLED IN THE ACADEMIC MENTORING PROGRAM TO HELP THEM OBTAIN THEIR GOAL OF A POST SECONDARY EDUCATION. THESE SERVICES ARE AVAILABLE MONDAY THROUGH FRIDAY BY APPOINTMENT IN THE ORGANIZATION'S MAIN OFFICE.
