We are committed to developing, leading, and supporting national, state, and local strategic campaigns, as well as worker organizing efforts in a variety of fast growing sectors, combining both organizing and public advocacy related efforts to ensure a win for workers and working families. In the last three years national campaigns we have launched or helped to launch include Caring Across Generations, Protecting Our Workers Against Exploitation and Retaliation (POWER), Worker Center Immigration, End Student Debt, Change Walmart Change the Economy, and numerous right-to-organize and collectively bargain campaigns. As an organization with a network of grassroots organizations we also provide financial and technical support to our local affiliates to effectively conduct outreach and public education activities related to workers' rights issues, and to engage in winning workplace justice and community campaigns focused on expanding access to health care coverage, protecting our public safety net programs like Medicaid/Medicare and Social Security, improving public education statewide, advocating for increased access to childcare services for low-wage families, and many more.
