ALASKA BALLOT INITIATIVE MPP formed a ballot-initiative committee in 2013, the Campaign to Regulate Marijuana Like Alcohol, for the purpose of passing a law in Alaska that's similar to the law that MPP passed in Colorado in November 2012 In 2013, CRMLA collected a sufficient number of signatures from registered voters, thereby qualifying the initiative for the statewide ballot in Alaska in November 2014 On Election Day in November 2014, the initiative passed with 53% of the vote This was MPP's biggest victory in 2014
