THE COLLABORATION OF THESE TEN AGENCIES PROVIDES ACCESS TO QUALITY EDUCATION, ARTS, HEALTH AND RECREATIONAL PROGRAMS. BBAR THROUGH MANAGEMENT, LEADERSHIP AND FISCAL OVERSIGHT OF "THEARC" SEEKS TO IMPROVE THE QUALITY OF LIFE FOR EAST OF THE ANACOSTIA RIVER RESIDENTS.

"THEARC" THEATER PLAYS AN IMPORTANT ROLE IN THE FULFILLMENT OF BUILDING BRIDGES' MISSION. BBAR CURRENTLY MANAGES THE OPERATIONS OF THE THEATER, A FUNCTION THE MAJORITY OF THE BBAR BOARD FELT IT WAS NECESSARY TO MAINTAIN ITS DIVERSIFIED PROGRAMMING AND KEEP IT AFFORDABLE FOR THE COMMUNITY. THE THEATER HAS MORE THAN OUT PERFORMED ITS INITIAL INTENT EXPERIENCING OVER 300 EVENTS IN A CALENDAR YEAR, AND IS THE ONLY THEATER IN WARD 8.
