The remaining Board or committee members shall decide if a conflict of interest exists (3) Procedures for Addressing the Conflict of Interest ----- (a) An interested person may make a presentation at the Board or committee meeting, but after the presentation, he/she shall leave the meeting during the discussion of, and the vote on, the transaction or arrangement involving the possible conflict of interest (b) The chairperson of the Board or committee shall, if appropriate, appoint a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement (c) After exercising due diligence, the Board or committee shall determine whether USOGA can obtain with reasonable efforts a more advantageous transaction or arrangement from a person or entity that would not give rise to a conflict of interest (d) If a more advantageous transaction or arrangement is not reasonably possible under circumstances not producing a conflict of interest, the Board or committee shall determine by a majority vote of the disinterested directors or committee members whether the transaction or arrangement is in USOGAs best interest, for its own benefit, and whether it is fair and reasonable. In conformity with the above determination, USOGA shall make its decision as to whether to enter into the transaction or arrangement (4) Violations of the Conflicts of Interest Policy ----- (a) If the Board or committee has reasonable cause to believe a member has failed to disclose actual or possible conflicts of interest, it shall inform the member of the basis for such belief and afford the member an opportunity to explain the alleged failure to disclose (b) If, after hearing the members response and after making further investigation as warranted by the circumstances, the Board or committee determines the member has failed to disclose an actual or possible conflict of interest, it shall take appropriate disciplinary and corrective action.</p> <p>ANNUAL STATEMENTS ===== Each Director, principal operating officer and member of a committee with Board-delegated powers shall annually sign a statement which affirms that such person has received a copy of this conflicts of interest policy, has read and understands the policy, has agreed to comply with the policy, and understands that USOGA, in order to maintain its federal tax exemption, must engage primarily in activities which accomplish one or more of its tax-exempt purposes.</p>
