Part III, Line 12, Income of the Ellicott City Senior Center Council includes only donations, fundraiser proceeds and interest credits on a bank checking account. The only asset is cash in the checking account. The ECSC Council owns no property but uses property of the ECSC. The ECSC Council consists of 15 senior volunteers elected by registered seniors of the ECSC. The members of the ECSC Council meet monthly with the Director and the Assistant Director of the ECSC to discuss programs and needs of the ECSC. The support given is a direct response to requests made by the ECSC staff. The ECSC is owned and operated by Howard County government. There is a County-wide Activity Fund for all senior centers in Howard County. Sometimes the ECSC Council sends checks to the Director of Finance, Howard County to be put in the Activity Fund, which is used to pay for scheduled programs or can be drawn on through use of their County Credit Card by the Director, Assistant Director, or Food Service Director. Some things are ordered directly from a company. The ECSC also puts cash directly into the ECSC Petty Cash Fund kept in the ECSC safe and used for needs not provided by Howard County government. In 2014 the ECSC Petty Cash Fund was used for Netflix for movies, donations for special events, gratuities for school groups for concerts, holiday gifts for seniors and volunteers at front desk, lunch desk, and kitchen; playing cards and two class refunds. The ECSC staff is not allowed to access the fund directly but makes requests to the ECSC Council, which keeps a ledger record of the ECSC Petty Cash Fund and replenishes the fund as needed.

Explanation for donation to Small Miracles Cat and Dog Rescue: The Assistant Director of the Ellicott City Senior Center chose this charity and advertised the Craft Boutique Fundraiser on December 3, 2014 as a combined fundraiser for both the ECSC Council and Small Miracles, a community animal shelter, in order to draw more community participation and sales for the professional crafters who rented tables at the Craft Boutique. All of the ECSC Council fundraisers are joint projects conducted by the ECSC staff and the ECSC Council and are at the ECSC. Because the ECSC does not have a checking account, the ECSC staff asked the ECSC Council to deposit the entire amount of proceeds from the Craft Boutique and write a check for \$500 to Small Miracles.
