SMALLHOLDER FARMERS. AT THE US-AFRICA SUMMIT, ACTIONAID CALLED ON THE U.S. AND AFRICAN GOVERNMENTS TO WORK TOGETHER TO SUPPORT THESE FARMERS. WE RELEASED A NEW REPORT JUST AHEAD OF THE SUMMIT, ARGUING FOR THE IMPORTANCE OF MAKING PUBLIC INVESTMENTS IN AGRICULTURE AND THE URGENT NEED FOR GOVERNMENTS TO STOP RELYING ON THE PRIVATE SECTOR TO SOLVE THE CHALLENGES FACING AGRICULTURE IN THE TWENTY FIRST CENTURY. EARLIER IN THE SUMMER AFRICAN GOVERNMENTS MET FOR THEIR OWN SUMMIT IN WHICH THEY COLLECTIVELY PLEDGED TO END HUNGER IN AFRICA BY 2025. OUR REPORT OUTLINED 10 RECOMMENDATIONS THAT COULD LEAD TO THE KIND OF TRANSFORMATION AFRICAN GOVERNMENTS ARE SEEKING. THESE RECOMMENDATIONS INCLUDED INCREASING INVESTMENTS FROM DONORS AND IMPROVING THE EFFICIENCY OF INVESTMENTS FROM AFRICAN GOVERNMENTS, DIRECTING INVESTMENTS AT STAPLE CROPS, WOMEN FARMERS, SUSTAINABLE AGRICULTURE, SIMPLE LABOR-SAVING TECHNOLOGIES, EXTENSION SERVICES, AND AGRICULTURE RESEARCH, SUPPORTING THE POLITICAL POWER OF SMALL-SCALE FARMER ORGANIZATIONS, STRENGTHENING LAND TENURE AND IMPROVING THE TRANSPARENCY OF AGRICULTURE BUDGETS. AT THE SUMMIT, WE SAW AFRICAN LEADERS AND THE U.S. GOVERNMENT UNITE AROUND A SHARED VISION FOR A BRIGHT FUTURE FOR AFRICA. WE WILL CONTINUE TO WORK TO HOLD THE U.S. AND OTHER DONOR GOVERNMENTS ACCOUNTABLE TO ENSURE THAT AN END TO HUNGER REMAINS PART OF THIS VISION, WITH AFRICA'S SMALL-SCALE FARMERS KEY TO THE TRANSFORMATION.
