We educated students on drug policies including those related to changing marijuana and other drug prohibition policies to be more sensible and less punitive, promoting harm reduction/overdose prevention practices, providing evidence-based drug education, and teaching students about international drug policy, racial justice, civil rights, human rights and their constitutional rights. The national staff organized six regional conferences on similar topics for more than 400 students and hosted a national conference with nearly 500 attendees. See Schedule O for continuation.
