AS A RESULT, THE ACTUARIAL INCREASE ALLOCATED TO EACH EMPLOYEE FOR 2014 WAS SIGNIFICANTLY LARGER THAN IN PRIOR YEARS. THE AMOUNTS REPORTED IN THIS FORM 990 WITH REGARD TO EMPLOYEE COMPENSATION IN PART VII DO NOT REPRESENT AMOUNTS ACTUALLY PAID TO AN EMPLOYEE, BUT MERELY A CALCULATED VALUE THAT COULD CHANGE AGAIN IN FUTURE YEARS, EITHER UPWARD OR DOWNWARD.
