During 2014 the Kirov Academy graduated 10 students with a high school diploma. The number of graduates in 2015 was 8. The student body for the academic year ending in May 2014 consisted of 82 students, while the enrollment as of September 2014 was 85 students. Over 860 dancers were auditioned during a six week audition tour early in the year that included 12 different cities in the United States. Many of these were selected to attend intensive training sessions held in the summer at the Kirov Academy. Total enrollment in the summer sessions was 251 students. Approximately 180 children from the Washington metropolitan area attended preparatory ballet classes at the Kirov Academy. In a partnership with the National Gallery of Art in Washington DC, students from the Kirov Academy offered a special performance as part of an exhibition of the work of Edgar Degas, entitled "The Little Dancer". The Kirov Academy also staged concerts which were held in our studios in May and December for the sake of parents and invited guests.
