Pregnancy Counseling - this program helps women in an unexpected pregnancy to understand and work through the alternatives, beginning with pregnancy testing and confirmation ultrasounds, enabling them to make informed decisions concerning the outcome of their pregnancies For women who decide to carry their babies to full term, AbbaCare provides training to prepare the clients for motherhood and helps to meet emergency material needs related to the pregnancy such as clothing and diapers, and also assists in meeting other emergency needs through limited financial assistance and referrals to appropriate community organizations There were 1858 client visits in carrying out this program

Pregnancy Prevention - This program (Sexual Integrity) is a creative approach to presenting sexual abstinence to children, teens, and young adults, using skits and learning games with role play and active audience participation It was created to foster a stong culture within our community of teens and young adults who choose sexual integrity (remaining chaste until marriage) by empowering them to make informed decisions regarding their sexual health There were 635 student participants in these presentations

Fatherhood - This programs is designed to help prepare expectant and new fathers for their vital role in the life of their child and its mother, and to encourage their choice for life It includes a one-time couples class focusing on the importance of a father in the home and the roles of each parent, a monthly For Men Only class to prepare them with essential child health and safety information, and one-on-one mentoring by male counselors who help them deal with their questions and concerns as new parents They receive material rewards such as car seats and bassinettes for participation Sixty-six men participated in this program
