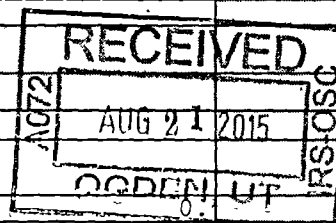

Part XV – Item 3: Supplementary Information Regarding Contributions Paid

During 2014, the Foundation expended funds to facilitate the formation of a new nonprofit organization dedicated to advancing education by fostering and cultivating affordable academic excellence at America's public colleges and universities. Expenditures of \$100,663.00 included consulting and legal fees, focus group meeting expenses and other miscellaneous expenses that directly lead to the formation of a dedicated nonprofit entity named Partners 4 Affordable Excellence @ EDU. In early 2015, the IRS granted 501(c)(3) status to this District of Columbia nonprofit corporation. This public charity was formed to promote investment in strategic programs and innovative research in public higher education and to stimulate public discussions relating to affordable academic excellence. This organization's main activity will be to make charitable grants to other organizations classified under section 501(c)(3) that are consistent with its mission.

A member of the initial Board of Directors of Partners 4 Affordable Excellence @ EDU is also a member of the board of The George & Grace Dragas Family Foundation.
