Every Autumn the Foundation, along with a group of other non-profit organizations in the mental health field, co-sponsors a conference on the issue of recovery from mental illness. The Foundation pays for the conference cost. The conference is open to the public and is well attended by individuals with mental health issues as well. The Foundation provides scholarships for individuals with mental health issues to be able to attend the conference.

4b (Code) (Expenses \$ 2,073 including grants of \$ 1,957) (Revenue \$)

Included among the grants the Foundation provides are those to groups of individuals who are currently in treatment for mental illness for basic needs and services to enhance the quality of their lives and aid in their recovery. The Foundation funds socialization activities such as outings and providing equipment for gardening, for individuals residing in government funded group homes.

4c (Code) (Expenses \$ 4,569 including grants of \$ 4,312) (Revenue \$)

Grants to individuals provided funding for necessary services for individuals with mental health challenges and recovery therefrom. Examples include: urgent dental care, job training, weight reduction programs, transportation farecards and ancillary therapy.
