Drug Court Program Initiative (DCPI) In 2014, National Drug Court Initiative (NDCI), under the Drug Court Planning Initiative Project, provided training to 531 drug court practitioners DCPI trained a total of a 9 adult team, 4 Tribal Healing to Wellness Courts and 34 Veteran Treatment Courts This cutting edge training is designed to assist local communities in the implementation of an adult, tribal and/or veterans' treatment court Each team was provided a three-day onsite training in their local jurisdiction which resulted in approximately the adult and veterans training two separate training sessions which resulted in NDCI conducting approximately 42 trips

Adult Drug Court Training Initiative (ADCTI) The overarching goal of the ADCTI is to improve drug court team functioning and to produce more effective services and better outcomes for drug court participants To accomplish this, the National Drug Court Institute (NDCI) increases the knowledge of adult drug court practitioners by 1 Maintaining an ADCTI web page, which lists a menu of trainings and learning objectives approved by the Bureau of Justice Assistance (BJA), 2 Conducting training needs assessments with applicants to ensure appropriate course selection, 3 Developing and implementing a prioritization process to fulfill training requests, 4 Evaluating training initiative events to determine customer satisfaction, 5 Developing Training-Of-Trainers (TOT) sessions to build capacity of state administrative court offices to meet training needs of drug courts within the states, 6 Updating curricula based on newly identified training needs and incorporating the latest drug court research findings in existing curricula, and 7 Maintaining a list of expert drug court training consultants Within the same fiscal year, the ADCTI project also provides training to 7,432 drug court practitioners through 25 Statewide Training Conferences and 19 On-Demand Training events These trainings provide drug court practitioners with the latest evidence-based practices based upon the science to assist them with improving their program outcomes

Annual Conferences - In 2014, NADCP held a historic joint conference the NADCP 20th Annual Training Conference and the second annual Veterans Court Conference These conferences, held in May in Anaheim, California, drew over 4,500 attendees from all fifty states and around the world They represented both the largest conference anywhere on addiction, mental health and the justice system, and the nation's only conference for professionals working in Veterans Treatment Courts With hundreds of groundbreaking sessions and evidence-based training on best practices for all disciplines represented on the Drug Court, Veterans Treatment Court, and other problem-solving court teams, the joint conference was the largest conference in NADCP history
