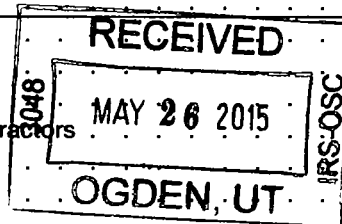

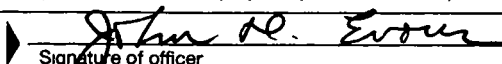

Part I Line 10 re: 9 Grants valued at \$16802. While all project activities took place in the Dominican Republic, the grants were technically made to the Peace Corps Partnership Program based in the US, so there were no foreign grants made. Four of the projects funded by our Community Challenge Fund Improved potable water systems, a major need in rural Dominican communities. The other three projects provided energy efficient cook stoves and community latrines. Our Program Support Fund, designed primarily to support Peace Corps program initiatives, made two grants related to a new DR government program intended to provide necessary identity documents. One was a training program for documentation promoters in a particular region, and the other was a national conference that brought together leaders and promoters involved in the documentation effort across the country and allowed them to share experiences and best practises.

Part I Line 16 re: Other Expenses \$115. These expenses represented the annual fee to affiliate with the Nat'l Peace Corps Association (\$80); the annual fee to the Virginia Corporation Commission to maintain our incorporated status in Virginia (\$25); and a bank fee charged for a returned check (\$10).

Part I Line 20 Change in Net Asset Values. According to statements received from American Funds, our mutual fund holdings in 2014 experienced a gain of \$3180 attributable to net changes in asset values.

Part III Foreign Grants. To clarify, we made no foreign grants in 2014. Our grants/donations were all made to the Peace Corps Partnership Program based in Washington, DC. Thus, when funds were transferred to the Peace Corps office in the Dominican Republic, they were then technically Peace Corps monies.
