Form 990, Part III - ART 180 offered 24 community programs, 10 teen programs, and 13 Friday workshops in 2014. The following is a sampling of the many programs we offered at. In Spring 2014, ART 180 offered community programs in partnership with Communities In Schools of Richmond. Henderson Middle School youth explored ways to tell stories about themselves through an accordion-fold book. Elkhardt Middle School they explored photography and writing to create Alphabet Autobiographies that combined interpretative photos and writings prompted by each letter of the alphabet. At Martin Luther King Jr Middle School youth learned how to create their own video game that allowed the players to learn more about the designers personality. Thompson Middle School created eight-foot tall cutouts of their silhouettes to show who they are on the inside and outside. Using improvisational theater techniques young artist at Lucille Brown youth experienced moments that made them uncomfortable, strengthened their powers of invention, and showed them that as long as you try you can't go wrong, which resulted in them hosting their own improv session. Middle-schoolers at Binford Middle School created kites adorned with painted images that represented each artist and their dreams. At Redd Elementary School the group explored ideas of family, community and personal space using hula-hoops. Franklin Military Academy students decorated oversized puzzle pieces to show how their perspectives come together within a group puzzle. They also created personal puzzles that showed their uniqueness and complexity. Club members at The Salvation Army Boys and Girls Club discovered what movement music and movement meant to them, by creating an interactive mural expressing the interplay of movement and music. Charterhouse School youth discussed fashion and personality through studying what clothing represents and what they wanted to say through the way they dress. At St. Andrew's School the young artist explored symbolism to help them create their own family crests. In our teen programs at Atlas, teens explored Urban design and how to build community though understanding the history and design of Jackson Ward. Hip-hop dancers learned to express themselves through individual and collaborative dances. In the music program teens collaborated to create original songs using drums ukuleles and other instruments. Mask-making helped the young artists explore different elements of their personality to create 3D masks that described them. The teens in the theatre program worked together to create an original theatrical performance. In graphic design the teens learned basic graphic design skills that helped them create pieces that spoke to issues that were important to them. Also in the spring we hosted eight Friday artist workshops in various mediums. Summer 2014 explored the art of radio storytelling in partnership with Richmond Behavioral Health Authority and local radio station WRIR. Their final recorded pieces were aired on community radio as well as premiering to a live audience. Our summer teen program learned the art of video production and created a short documentary focusing on identity and stereotypes. In Fall 2014, ART 180 offered community programs in partnership with Communities In Schools of Richmond. Through a study of the art of the flow Henderson Middle School students found the right beat, learned how to handle their emotions and dealt with problems through the power of their words. Elkhardt Middle School used cultural symbols and found objects, to create a symbolic representation of the person behind the mask themselves. They came to a personal understanding of themselves as something not to hide. Thompson Middle School students explored their character traits and constructed totem pole styled monuments adorned with symbols representing themselves. Students at Lucille Brown Middle School experimented with various forms of photography to better understand the art. They crafted photo essays based on the life of an imaginary character they created. Middle-schoolers at Binford Middle School used paneled comics to identify problems and imagined solutions. They worked to create characters and scenarios to share their story. The drawn language gave them the chance to show the world what they would do if they were the heroes. At Redd Elementary School zines offered these makers a chance to create and share thoughts, feelings and opinions, and a chance to be heard. Their personal magazines reflected their true character and a sense-of self-empowerment. Fairfield Middle School students learned how to create their own video games and build systems that answered the question How can you make your community better? At The Salvation Army Boys & Girls Club the young people learned about stand up comedy and how humor can be a powerful tool for change. Students at Northstar studied word interpretations. They created a visual representation of words they felt shared their view of life. The paintings were done on fabric and attached to create a piece of wall art. Charterhouse School youth took a deeper look into what it means to be different, unique, strange, or absurd. Through writing, they discovered a voice to share these thoughts. At St. Andrew's School young people crafted pieces of art reflecting on important people in their lives. Their art pieces were created to be mailed. Each piece in the series traveled farther away expanding the circle of their lives through each offering. Fall teen program at Atlas explored zine making focused on their past present and future selves. In window painting teens created paintings on salvaged windowpanes that offered a look into the teens lives, aspirations and views on the world around them. Hip-Hop dance offered teens the chance to explore themselves through music and movement individually and as a group. Five artist workshops were held during the fall. The impact to the community through programs for 2014 was 522 young people served and 12,596 people were exposed to ART 180 through exhibitions workshops performances and annual showcases.
