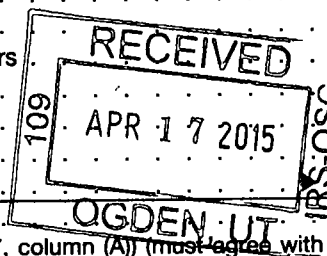



Survivor Vision (SV) is organized and operated to attract public support on a continuing basis. The organization maintains bona fide programs for obtaining funds from the public, including the solicitation of donations through its web site, networking, mailings, various public fundraising events, Paypal and Amazon.com. In addition, the organization distributes periodic communications, maintains a presence on Facebook, and participates in a number of public events, including 5k events for charitable causes.

Survivor Vision is an 8 year old organization with a small staff that is constantly looking for ways to generate additional public funds, despite a difficult and competitive market. SV continues to solicit new public donors and increase the awareness of the organization. Its fundraising efforts are reasonable in light of its charitable activities. Each year SV supports pediatric oncology survivors and fighters, as well as their families, through to a diverse spectrum of organizations who maintain or support programs and services that seek to improve their lives. All funds raised by the organization are used to satisfy SV's mission. The organization pays no salaries, and investment income of \$217 is less than 1% of total revenue.

SV's public support percentage for 2014 was 100%, as it was in 2013. While SV's 5 year public support is 14 1% of its income, it should be noted that for several years the organization was the beneficiary of one generous donor. Excluding those donations, SV's public charity % is close to or equal to 100%. SV maintains a very low level of administrative expenses, all of which are incurred in an effort to generate public donations.

SV's governing body is made up of eight people with diverse personal and professional backgrounds and experiences, including financial professionals, attorneys, salespersons, and medical and business professionals. In addition, many board members have medical knowledge, a key to understanding and executing the organization's mission. Furthermore, the organization's founder herself is a pediatric cancer survivor, who created the organization's vision and mission from first hand experience. SV assists, directly and indirectly, thousands of children and families each year through a number of programs and grants distributed throughout the nation. SV's primary program is its textbook scholarship program, which encourages pediatric cancer survivors to take responsibility for their education, as they move forward with trying to live a normal life.
