We completed a series of technical studies and prototype hardware demonstrations for Sentinel Mission. In 2014, we also formed the SODA working group that constructed a software model to guide observatory operations relating to asteroids. The B612 team published articles in various magazines and wrote a scientific position paper on Sentinel Mission. The team also presented at scientific conferences and spoke at corporations, museums and other forums, including TED 2014/Canada and the Planetary Defense Conference/Italy. Finally, B612 was a primary founder of Asteroid Day, a global awareness campaign held on the anniversary of the largest asteroid impact on Earth in recent history. The B612 team has become widely acknowledged as the leading experts on asteroid discovery and planetary defense.
