Provide financial support for 535 needy Haitian families. A child sponsorship/scholarship program keeps hundreds of children in school, assists their families, and helps support the teachers and free school lunches.

4b

(Code) (Expenses \$ 73,286 including grants of \$ 73,286) (Revenue \$)

Provide medical treatment for 2,500 needy residents of Ft. Liberte, Haiti. Acute care, maintenance and general health promotion is provided to the community through the Eben Ezer clinic, staffed by a Haitian doctor and local nurses and auxiliary personnel and in cooperation with the local health ministry. The clinic serves the community each weekday and for emergencies. Acute and chronic problems are addressed and patients are often referred and covered for eye exams, dental work or surgery. The staff is supplemented by visiting American medical teams and medicines, supplies and equipment are provided by the teams and FFL to keep the clinic open. FFL supports the local Health and Human Services and that for specific health issues no one is turned away based on ability to pay, race or religion.

A home for orphan children is provided at the King Orphanage in Ft. Liberte. The orphanage provides housing, food and clothing for as many as 50 selected orphans. Enrollment in the sponsorship/scholarship program may also provide homes for children with families who can then afford to take them in.

To support FFL's mission statement of relieving homelessness and hunger, promoting education and individual potential through JBC, Ft. Liberte, Haiti, and its programs, FFL monitors donations and expenditures in several ways. One way is to assign the depositing of donations and the paying of bills to different board members. Separate accounting is kept for individual programs and for operating expenses. A financial committee reviews and oversees all these procedures and an accounting firm is engaged to assist with the bookkeeping and accounting. An outside audit is done each tax year.
