Hunger Relief.

In 2014, our staff guided more than 2,800 volunteer participants through Hunger Challenge events in five different cities. Those volunteers assembled packages of soy, vitamins, dehydrated vegetables, and rice, and prepared the food for shipment overseas. More than 563,000 meals were packaged and shared with Christian missionary partners in the Philippines, Burkina Faso, and the Yucatan Peninsula of Mexico.

Discipleship through Foreign Missionary and Pastor Support.

Heaven Sent Ministries supports the work of Christian missionaries and pastors all over the world, including the Discipleship Training Center operated by our NGO in Ghana. The ministries we support care for refugees and orphans, train pastors and other Christian leaders, provide medical care, run schools, provide vocational education, and as well as other aid.

International Mission Trips.

Our staff organized travel for 43 volunteer participants on short-term mission trips during 2014. Family groups, individuals, and church teams traveled to work alongside missionary partners to provide medical care, assist with construction projects and facility repair, work with children in orphanage settings, teach English, establish a sewing business for women in poverty, minister to refugees, and generally assist with the work of God's kingdom all over the world.
