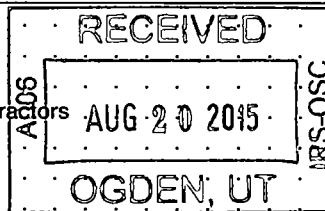

**Part I Line 8 - Other income consists of registration fees, etc. from the Southern District Institute of Transportation Engineers (SDITE) Annual Technical Meeting (registration fees, etc). The meeting was held in Greensboro, Georgia March 30 – April 2, 2014. The meeting was attended by 355 people, including members, affiliates, spouses, guests and students. The meeting featured forty-seven (47) technical sessions on a wide variety of transportation topics and two technical tours. The meeting included vendor displays, student activities and an Executive Board Meeting and a Business Meeting for the membership.**

**Part I Line 10 - Grants consists of several types of grants. The first was support grants to Student Chapters of the organization (typically \$100 to each active student chapter with slightly higher amounts to the chapters judged to be the best and second best - total distributed in 2014 was \$2,850). Additional support was made to student chapters to send students to the SDITE Annual Technical Meeting in Greensboro. Grants were made to state chapters to assist in hosting Leadership Development Training courses (courses are taught by member volunteers and grants only cover course expenses such as meeting rooms, copies of materials, etc. ).**

**Part I Line 16 - The largest part of Other Expenses consists of expenses for the SDITE Annual Technical Meeting held in Greensboro, Georgia on March 30 – April 2, 2014 (355 in attendance). Expenses included hotel meeting space, A/V equipment, meals, transportation for off-site technical tours, etc. Line 16 also included travel assistance for students to attend and participate in the meeting.**
