Programs of the
Foundation for Biblical Study

The mission of the **Foundation for Biblical Study** (FBS) is the faithful teaching (and distribution) of scripture and the training of teachers in congregations in the love of God in Christ. FBS works directly with the *Christian Resource Center* (CRC) in St. Petersburg, Russia which supports and promotes this mission with Russian speaking believers. CRC Russia manages this mission through leadership training (ITCM), teaching students (RBS) and encouraging congregations (www.CRCRussia.com/index.php/en).

The *Russian Bible School* (RBS) began in 1991, sending Bibles and Christian literature to more than 100,000 Russians who wrote in response to the first Christian nation wide radio programs on RadioOne. The work was expanded when the children of Brentwood Oaks Church of Christ in Austin, TX collected money to translate *The Beginners Bible* into Russian and the children's Bibles were distributed throughout Russia through RBS. Since then, RBS has sent more than 120,000 bibles, 30,000 new testaments, 95,000 works of Christian literature, and countless cassettes, DVD's, and informational letters. Today RBS has, in addition, a robust on line program, corresponding with 1,000s of Russian speaking seekers annually (www.CRCRussia.com/index.php/en/learnen)

The *Institute of Theology and Christian Ministry* (ITCM) currently trains servant-leaders of existing Russian-speaking congregations through the use of on-line courses. ITCM began as a two year residential school in St Petersburg Russia, with 33 graduates over 5 years. Because of the size of Russia, it was determined, however, that more students could be reached, in far reaching corners of Russia (and Ukraine), through courses on the internet (www.CRCRussia.com/index.php/en/teachen).

The third expression of the mission of CRC entails the encouragement to faith, hope and love of the scattered congregations in Russia. Through conferences, seminars, singing workshops, a monthly newspaper (called "In Christ"), social media sites and a website listing the congregations (www.churchofchrist.ru), CRC intends the planting and watering of churches.
