With Love From Jesus Ministries serves the community's less financially-privileged populations through the provision of spiritual support, food, clothing, household items, furniture, and other items provided through contributions from churches, businesses, other groups and individual donors. There is no cost to our honored guest for any of these items or services. The good news of the Gospel of Jesus Christ is always freely given in both English and Spanish during the initial welcome of our honored guests. Every volunteer strives to extend the love of Jesus Christ throughout the visit of each and every honored guest that we serve (and everyone who enters our facility is seen as an honored guest).

With Love From Jesus Ministries operates out of approximately 20,000 square feet in an old and gutted grocery store. While we have lights and electricity, our space has no heating, air conditioning, or windows other than entrance/exit doors and a loading dock. We continue to strive to be good stewards of the resources that God has richly provided us with. Without heat and air conditioning, the concrete floors and lack of window ventilation causes many sacrificial challenges for our volunteers and staff. However, we are blessed through the coming together of His people in a special way that shows this needy world how His people can be unified through the power of His name as we serve and share His love to others and among ourselves.

With Love From Jesus Ministries is continually reviewing our operations and expenditures in order to keep our administrative costs as low as possible so that we can focus on the truth of the ministry. The Board of Directors is provided with revenue and expenditure account summaries each month, and prior year information is provided in the same Excel spreadsheet by email transmittal. Employees working for the Ministry are overseen on a daily basis by our on-site Executive Director or her managerial designee. Compensation for our employees is reviewed annually against that of similar non-profit operations to help ensure that our costs in this area bring only honor to Him in whose name we serve. Our commitment to integrity and transparency is seen through our membership in the Evangelical Council for Financial Accountability (ECFA) and information on our costs as provided through our Form 990 and supplemental schedules can be viewed at www.ECFA.org by doing a search on our corporate name.

Our honored guests who are receiving these services are not asked to provide any type of eligibility and no selection criteria is used. Everyone who comes for assistance is welcomed in the name of Jesus Christ and their needs are freely met with all the items which have been donated. We serve approximately 1,200 guests per week, so an approximate figure of 60,000 was used (i.e., 1,200 times 50 weeks).

2 - With Love From Jesus Ministries also provides limited monetary assistance in emergency situations whereby an honored guest is in dire need of funds to help prevent immediate cessation of needed utilities for example. These funds are sent directly to the church sponsoring the individual honored guest (except in 1 case where the apartment complex received). While the food, clothing, and other non-cash items provided by the ministry are certainly much needed (and remain the vast majority of our giving to honored guests), on certain occasions utility payments and the like can be equally important if not greater for our honored guests.
