Direct benevolence and economic assistance was provided to those in crisis and at risk of becoming homeless. 4,518 clients were assisted with the following needs: utilities, rent, mortgage, transportation, medical expenses, and food. The largest need by dollars spent was utilities at 82.1% of benevolence funds distributed in 2014. The largest need by individuals served was food at 76.5% of clients served in 2014. Individuals are interviewed 2-4 mornings each week to determine need for assistance and to verify all information. Food is distributed up to six hours per week with verification of identity, family size, and health or age-related issues.
