The Summer Health Internship Program (SHIP) provides high school students with internships the health care field The program places these students in six-week placements in hospitals, and community health care centers Students spend three days a week at a local hospital or health center and one day a week at a didactic session focused on health careers and community health issues Interns have the support of more than eighty health care professionals (including doctors, dentists, nurses, technicians) as workshop presenters and mentors Thirty four students participated in the SHIP program in 2014The Medical Academy of Science and Health Camp (MASH) offer middle school and high school students the opportunity to spend one day visiting the various departments of a hospital and becoming aware of the various careers in the health field The goal of MASH is to provide a fun learning experience for youth and to promote health professions as a career choice BQLI AHEC staff conducted eight MASH camps in 2014The Community Health Experience a collaboration between the three New York City Area Health Education Centers provide a community based internship to students who have completed the first year of medical school at the New York College of Osteopathic Medicine Twenty medical students were placed at community based internship sites in 2014 The Health Careers Opportunity Program (HCOP) at SUNY Downstate Medical Center, expose students to health career information and provide hands-on learning opportunities for students For five weeks, the students go on excursions to hospitals and medical facilities and attend workshops held by nurses, social workers, doctors, and various other health professionals In 2014, 75 students participated in the HCOP program,New York City Department of Education, Health Industry Advisory Commission BQLI AHEC staff coordinated an annual health career conference for NYCDOE teachers and administrators in November, 2014 This served as a professional development activity for teachers who wanted to learn about emerging health careers and health internship opportunities for their students Approximately 60 teachers and administrators participated in the conference Health Leadership Awards Gala BQLI AHEC held its 3rd annual health leadership awards dinner dance to raise funds for the organization and to thank the over 15 hospitals and health centers that have provided internships and mentorship to participating students over the past twelve years of the programs operation The event also recognized past students that have completed the program and are now completing a graduate health profession program or working in the health professions The event was a huge success and was attended by over 100 individuals Oral Health Workforce Educational Program Through a grant from the New York State Department of Health, BQLI AHEC coordinated a symposium to educate dental students about the various loan repayment and scholarship opportunities available through the National Health Service Corps Approximately 50 students were in attendance Ambassadors for Coverage program Through a grant from the Justice Center, BQLI AHEC conducted numerous outreach activities to educate the public about health insurance options under the New York State of Health marketplace Brooklyn Nursing Partnership Symposium The BQLI AHEC staff coordinated a health symposium in collaboration with the Brooklyn Nursing Partnership, a coalition of Brooklyn nursing faculty and Chief Nursing officers to assess the impact of the implementation of the Affordable Care Act on Brooklyn nursing staffing Over 80 people were in attendance
