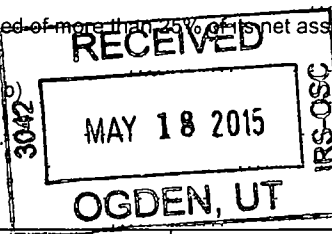

THE ORGANIZATION AWARDS GRANTS TO LOCAL ARTS ORGANIZATIONS, INDIVIDUAL ARTISTS AND ARTS EDUCATION PROGRAMS IN GREENVILLE COUNTY, SOUTH CAROLINA. IN 2014, IT AWARDED OPERATING SUPPORT GRANTS TO NINE ARTS ORGANIZATIONS AND PROJECT GRANTS TO 88 OTHER ARTS ORGANIZATIONS AND INDIVIDUALS WERE COMPLETED IN 2014. THESE GRANTS HAVE ALLOWED ARTISTS AND PRESENTING COMPANIES TO EXPAND THEIR PROGRAMS AND SERVICES. SUPPORT MADE TO LOCAL SCHOOLS IS VITAL IN ENSURING THE ARTS REMAIN AN IMPORTANT PART OF SECONDARY AND HIGHER EDUCATION. PROJECT SUPPORT GRANTS HAVE ALSO ALLOWED INDIVIDUAL ARTISTS TO TRAVEL TO DIFFERENT PLACES TO ENHANCE THEIR ABILITIES WHILE BEING GREAT AMBASSADORS FOR THE GREENVILLE ARTS SCENE.

THE ORGANIZATION HOLDS VARIOUS ARTS FESTIVALS DURING THE YEAR. THE GALLERY IS HOME FOR THE ANNUAL GREENVILLE OPEN STUDIOS EXHIBIT IN NOVEMBER, THE ONE-STOP OPEN STUDIOS RETROSPECTIVE IN APRIL-MAY, AND THE FLAT OUT UNDER PRESSURE EXHIBIT IN JUNE. ARTISPHERE DRAWS CROWDS OF 100,000 DURING THE MAY WEEKEND. DOWNTOWN ALIVE 2014 FEATURED INDIVIDUAL ARTISTS AND ARTS ORGANIZATIONS IMPLEMENTED IN 2012. A NEW FEATURE OF THE EVENT IS THE ARTS DO DOWNTOWN ALIVE WHICH WAS DESIGNED TO GIVE AND CREATE GREATER AWARENESS OF METROPOLITAN ARTS COUNCIL'S INDIVIDUAL ARTISTS AND ARTS ORGANIZATIONS. EVERY THURSDAY, THESE ARTISTS AND GROUPS ARE ALLOWED TO SELL THEIR WORK AS WELL AS TICKETS TO PERFORMANCES.

SMARTARTS IS A PARTNERSHIP BETWEEN GREENVILLE COUNTY SCHOOLS AND THE METROPOLITAN ARTS COUNCIL THAT CONNECTS STUDENTS, ARTISTS AND TEACHERS TO DEEPER LEARNING AND SELF-AWARENESS THROUGH INTEGRATING THE ARTS WITH ALL AREAS OF EDUCATION. ARTS INTEGRATION IS THE COLLABORATION BETWEEN THE ARTS AND OTHER CONTENT AREAS RESULTING IN A RICHER, MORE COMPLETE WHOLE THAT FOSTERS DEEP, CONNECTED, PERSONAL LEARNING IN BOTH AREAS SIMULTANEOUSLY. THE ORGANIZATION HAD 54 PARTICIPATING SCHOOLS IN GREENVILLE COUNTY FOR THE 2013-2014 SCHOOL YEAR.
