AFTER YEARS OF STRUGGLING TO CREATE HEALTHCARE OPPORTUNITIES FOR SOUTH CAROLINIANS WITHOUT HEALTH INSURANCE, THE PALMETTO PROJECT BEGAN WORK IN THE FIRST OPEN ENROLLMENT FOR THE FEDERALLY FACILITATED HEALTH INSURANCE MARKETPLACE AS A SUB-CONTRACTOR TO THE STATEWIDE NAVIGATOR GRANTEE. THIS WORK BEGAN IN LATE 2013 AND CONTINUED THROUGH THE END OF THE GRANT PERIOD IN OCTOBER 2014. AT THAT TIME, PALMETTO PROJECT WAS AWARDED THE STATEWIDE NAVIGATOR GRANTEE CONTRACT FOR THE SECOND OPEN ENROLLMENT SEASON, WHICH BEGAN IN NOVEMBER 2014. OUR WORK AS HEALTH INSURANCE NAVIGATORS ALLOWED US TO CONNECT THE UNINSURED WITH OPPORTUNITIES FOR AFFORDABLE HEALTH INSURANCE COVERAGE THROUGH BOTH THE FEDERALLY FACILITATED MARKETPLACE AND SC HEALTHY CONNECTIONS MEDICAID. IN 2014, PALMETTO PROJECT ASSISTED 7,108 INDIVIDUAL ENCOUNTERS (BOTH IN-PERSON AND BY PHONE) AND HELD 137 OUTREACH AND EDUCATION EVENTS, REACHING A TOTAL OF 96,408 INDIVIDUALS.
