At year end, the Ad Hoc Compensation Committee approves the final scorecard number and reports results to the full board. Annual incentives for the executives are based on 60% on the corporate scorecard and 40% on individual performance. Executives maintain an individual scorecard on the leader evaluation manager and discuss results monthly with the President/CEO. The President/CEO approves the individual executive scorecard. System Vice Presidents and the system CEO are eligible to participate in a long term incentive plan (LTIP). An LTIP plan typically takes place over a three year period and does not vest until the end of the third year. To receive payment, executives must still be employed by the system at the end of the plan period. Each LTIP plan has a financial and clinical objective that is aligned with the organization's strategic goals. Threshold, target, and maximum performance ranges are established for these objectives and are measured based on performance against similar organizations or compared to an internal metric such as an improvement over prior performance. These targets and objectives are approved by the ad hoc compensation committee. The incentive is earned based on the satisfaction of the threshold, target, or maximum performance ranges. The Ad Hoc Compensation Committee also approves the final LTIP performance score and the amount paid to executives under the plan. Results are reported to the full board annually.

Part II, Line 1 Compensation from unrelated organizations	Carolinas Healthcare System provides the compensation of David L. Dunlap, CEO, Carealliance Health Services and Bret D. (6 board members), and Carolinas Healthcare System (1 board member). None of the 13 appointed board members receive compensation for their membership. The Foundation is charged with identifying, securing, and managing financial resources to support facility projects and healthcare services for the system's three hospitals, Roper Hospital, Bon Secours St Francis Hospital and Mt Pleasant Hospital, as well as 110 additional facilities located across the Low country. Gifts to the Foundation fill the gap between the healthcare system's operating revenue and the resources required to update our facilities, purchase the latest technology, and provide expanded access to care and other community health needs. In 2014, the Foundation raised more than \$7.6 million to improve the health and well being of Low country citizens and to advance the healthcare system's mission of healing all people with compassion, faith and excellence. Donor generosity helped to fund nearly 26 programs and departments within the Roper St Francis system impacting the greater Charleston community. These initiatives included the Center for Spinal Cord Injury, neuroscience and stroke services at Roper Rehabilitation Hospital, the Donna Fielding Cancer Wellness Institute, and nursing scholarships. The three largest program services supported by the fundraising efforts of the Roper St Francis Foundation in 2014 were: The Ryan White HIV Program, which receives federal, state, and local grants as well as support from private foundations, served more than 700 residents with HIV/AIDS through navigation, housing, and medication services. Roper Rehabilitation Hospital received gifts to expand their specialized neuro and stroke services to better meet the needs of our patients. The expanded services will help patients with disabling injuries or illnesses, such as a stroke, brain injury, or spinal cord injury, reach their highest possible level of independence. The Clinical Biotechnology Research Institute received gifts and grants to give patients access to the newest treatments and clinical trials available for varied conditions. The Institute is establishing an intellectual research hub to develop new therapies in the Low country. The Foundation's Board of Directors is an advisory board comprised of community leaders who provide guidance and advice regarding the fundraising mission of the organization. New members of the Foundation Board are nominated by the existing board and then, if approved, are elected by the Board of Directors of Roper St Francis Healthcare. Members of the Foundation Board of Directors and the Foundation's Executive Director sign an annual conflict of interest agreement administered through the healthcare system's governing Board of Directors.
