Breast Cancer License Tag Awards

Georgia CORE administers the Access of Care, Treatment and Services (ACTS) breast cancer grant on behalf of the State office of Rural Health of the Georgia Department of Community Health. In 2013/2014, Georgia CORE distributed proceeds from the sale of Georgia's Breast Cancer License Tags totaling \$2.3 million to 22 non-profit organizations to assist medically underserved women in receiving breast cancer screening and services. Georgians purchased/renewed 52,000 tags each year; \$22 of each tag sold is used to fund the ACTS program. Georgia CORE is responsible for promoting tag sales/renewals through websites, social media, presentations and printed materials.

Research & Genomics

Georgia CORE is a main member of the NCI's Gynecologic Oncology Group. CORE provides research network services to support accrual to clinical trials for academic and community based cancer centers across the state. Collectively nine affiliates of the Georgia CORE GOG Consortium enrolled 225 patients on clinical trials; one quarter of patients are racial/ethnic minorities. Georgia CORE is a partner in the newly funded NCI Community Oncology Research Program (NCORP) with Northside Hospital Cancer Institute and St. Joseph's Candler/Lewis Cancer and Research Pavilion. Georgia CORE coordinates the NCORP's research network among partners and members including the Amos Cancer Center, Harbin Clinic, Navicent Health and

Cancer Survivorship

With funding from Tom & Karen Chapman, Georgia CORE launched the Cancer Survivorship Connection, an online interactive site designed to bring tools, resources and support to survivors to enhance quality of life. An Advisory Board of cancer survivors was established to design the website; 8,000 survivors utilized the service in its first year of operation. Focus groups of survivors and navigators were convened to evaluate the website; their feedback will drive improvements in design and content in 2015. Georgia CORE partnered with the Rollins School of Public Health at Emory University and members of Georgia's Cancer Control Consortium to conduct a statewide needs assessment of survivors; results of 750 surveys will be

Income from the Organization's activities not directly related to the Organization's tax-exempt purposes is subject to taxation as unrelated business income. For the year ended December 31, 2014, the Organization had no unrelated business income and, accordingly, no unrelated business income tax. The Financial Accounting Standards Board has issued an Interpretation clarifying when an uncertainty in income taxes should be recognized or disclosed in the Organization's financial statements. The Organization has reviewed its tax positions and has determined that there are no tax uncertainties requiring recognition or disclosure for the years open to potential IRS examination (2011-2014).
