ANIMAL SHELTERS - In 2014, the Atlanta Humane Society provided care and found homes for 7,340 animals surrendered to our facilities. In addition to accepting animals from the metropolitan Atlanta community, animals were transferred from other animal organizations throughout the Southeast to our shelters for adoption. AHS also actively participated in the rescue and rehabilitation of animals from puppy mills, animal hoarding situations and dog fighting operations. A total of 11,599 animals were spayed or neutered in an effort to combat the pet overpopulation issue in our community, including 6,397 surgeries performed as part of our low-cost, high volume spay/neuter program.

VETERINARY CLINIC - The Atlanta Humane Society also operates a full-service charitable veterinary clinic providing affordable care for the public. In 2014, 5,458 animals received services at our clinic, with nearly 10% of services being rendered at low or no cost.

OUTREACH - Staff and volunteers gave numerous humane education tours of our facilities and presentations to the general public, including school groups as well as youth groups such as the Boy Scouts/Girl Scouts and the like. These presentations focus on the proper care and treatment of animals as well as the importance of spay/neuter. Additionally, Atlanta Humane Society is fortunate to have over 600 dedicated and active volunteers assisting in the day-to-day operations of the organization. Activities include routine animal care, special events as well as administrative support, with over 93,201 hours being contributed throughout the year.
