Under the terms of the agreement with the Community Foundation, fund principal can be distributed only with the approval of three-fourths of the Trust Fund's Board of Directors and a majority of the Board of Directors of the Foundation. The Foundation makes annual distributions of income available, which are unrestricted to the Trust Fund.
Pt V, Line 4	(2) Special Fund - This fund consists of the Pless bequest, which consists of funds temporarily restricted to capital improvements for the libraries in the system, as well as unrestricted and temporarily restricted monies that are transferred into this account for investment purposes. Under the terms of the agreement, fund principal can be distributed with the approval of the Board of the Trust Fund. Pless investment income & gains are not restricted by the bequest and are considered unrestricted.
