ALL SERVICES ARE FREE AND CONFIDENTIAL. 88 WOMEN AND 111 CHILDREN WERE SHELTERED IN 2014 FOR A TOTAL OF 11,605 GUEST NIGHTS. OF THESE BED NIGHTS, 4,956 WERE PROVIDED IN THE EMERGENCY SHELTER AND 6,421 WERE PROVIDED IN GATEWAY'S TRANSITIONAL HOUSING.
