The Community Foundation is the venture capitalist of the local charitable sector, supporting the Outer Banks's most exciting projects and most urgent needs. The Community Foundation is the only funding source that reaches all types of charities across the Outer Banks, supporting programs in the arts, education, health and human services, historic preservation and the environment. Also in 2014 the Foundation paid more than \$137,000 in scholarships to more than 85 local students, helping students of all ages across the Outer Banks achieve their educational goals.
